





DESCRIPTION/ORDERING INFORMATION

The TL720M devices are monolithic integrated low dropout voltage regulators offered in 3-pin TO packages. An input voltage up to 45 V is regulated to V_{OUT} of 5 V with 2% tolerance. The devices can drive loads up to 450 mA and are short-circuit proof. At overtemperature, the TL720M devices are turned off by the incorporated temperature protection.

The input capacitor (C_{IN}) compensates for line fluctuation. Using a resistor of approximately 1 Ω in series with C_{IN} dampens the oscillation of input inductivity and input capacitance. The output capacitor (Cout) stabilizes the regulation circuit. Stability is specified at $C_{OUT} \ge 22 \,\mu\text{F}$ and ESR $\le 5 \,\Omega$, within the operating temperature range.

The control amplifier compares a reference voltage to a voltage that is proportional to the output voltage and drives the base of the series transistor via a buffer. Saturation control as a function of the load current prevents any oversaturation of the power element. The device also incorporates a number of internal circuits for protection against:

- Overload
- Overtemperature
- Reverse polarity



3	OUT	Output. Connect to ground with ≥22-μF capacitor, ESR < 5 Ω at 10 kHz.

OUTPUT VOLTAGE vs JUNCTION TEMPERATURE



OUTPUT VOLTAGE VS INPUT VOLTAGE



OUTPUT VOLTAGE vs JUNCTION TEMPERATURE



OUTPUT CURRENT vs JUNCTION TEMPERATURE






Figure 5. CURRENT CONSUMPTION vs OUTPUT CURRENT



CURRENT CONSUMPTION vs OUTPUT CURRENT



OUTPUT CURRENT



CHARGE CURRENT vs JUNCTION TEMPERATURE



FREQUENCY



POWER-SUPPLY RIPPLE REJECTION vs FREQUENCY



FREQUENCY






Figure 13. Test Circuit



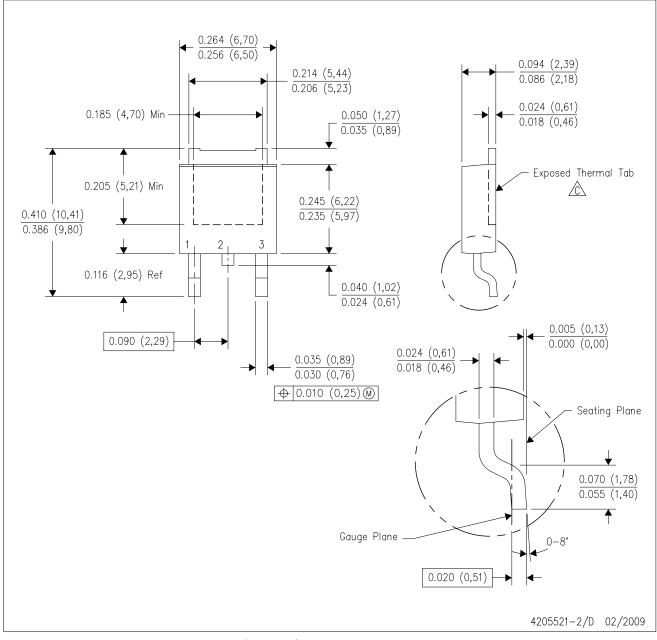
